



## **Privacy Policy – Overview**

### **Policy No. 2**

Fairholme Disability Support Group Inc recognises the importance that the community places on the confidentiality of individuals' personal and/or sensitive details and on how organisations manage the information they collect and hold regarding individuals.

The Privacy Amendment (Private Sector) Act 2000 (effective 21st December 2001) sets out guidelines on how private sector organisations (such as Fairholme Disability Support Group Inc ) should treat personal and/or sensitive information they collect and hold on individuals.

Fairholme Disability Support Group Inc is committed to respecting the rights of individuals, including their expectations of privacy, and fully supports the principles contained within the legislative privacy guidelines.

### **Privacy Policy**

#### **Information Collection and Use**

Fairholme Disability Support Group Inc [the Group] is the sole owner of the information collected on this site. The Group will not sell, share, or rent this information to others in ways different from what is disclosed in this statement.

#### **Cookies**

A cookie is a piece of data stored on the user's hard drive containing information about the user. Usage of a cookie is in no way linked to any personally identifiable information while on our site. Once the user closes their browser, the cookie simply terminates. If a user rejects the cookie, they may still use our site.

#### **Log Files**

The Group uses IP addresses to analyse trends, administer the site, track user's movement, and gather broad demographic information for aggregate use and analysis. IP addresses are not linked to personally identifiable information.

#### **Sharing**

The Group may share aggregated demographic information with our partners and advertisers. This is not linked to any personal information that can identify any individual person. Such information enables us to better tailor our content to readers' needs and to help better understand the demographics of our audience.

#### **Links**

This web site contains links to other sites. Please be aware that The Group is not responsible for the privacy practices of such other sites. The Group encourages our users to be aware when they leave our site and to read the privacy statements of each and every web site that collects

personally identifiable information. This privacy statement applies solely to information collected by this Web site.

### **Newsletter**

If a user wishes to subscribe to the Group newsletter, we ask for contact information such as name and email address. The Group may also ask optional demographic questions such as age, income, education level, and gender. This is not linked to any personal information that can identify any individual person. Such information, in aggregate, enables us to better tailor our content to members' needs and helps better understand the demographics of our members.

Users may have their email addresses removed from the opt-in mail subscription at any time by following the instructions printed on the website.

### **Security**

This website takes precautions to protect our users' information. When users submit sensitive information via the website, their information is protected both online and off-line.

### **Notification of Changes**

If the Group decides to change its privacy policy, we will post those changes on our Homepage so our users are always aware of what information we collect, how we use it, and under what circumstances, if any, we disclose it. Users will have a choice as to whether or not the Group use their information in this different manner. The Group will use information in accordance with the privacy policy under which the information was collected.
